Below we inform you how your personal data will be processed.

Data controller

The Data Controller is ACETI MACCHINE SNC, with registered office at Via ai Dossi n.32, Bolgare, 24060, BG.

Why we process your data We

will use your personal data: • To

provide the requested service/product and to fulfill the related legal obligations for the following purposes:

1. acquisition of information prior to providing the service/product (e.g. estimates);
 2. management of the provision of the service/product, invoicing and payment management;
 3. fulfillment of tax, accounting and legal and/or regulatory obligations that our company is required to comply with respect;
- For the legitimate interest of the ACETI MACCHINE SNC company in protecting company property, and for your interest to be protected while in our company for the following purpose:
 4. video recording through a video surveillance system;
 - For the legitimate interest of the ACETI MACCHINE SNC company to update its customers on the latest news products/services offered for the following purpose:
 5. sending communications of invitations to fairs and events or updates of catalogues and price lists; You may ask at any time to no longer receive such communications.

Need to provide us with your data

Your data is necessary for all the purposes indicated in points 1, 2, and 3; therefore, if you decide not to provide us with your data, we will not be able to guarantee the provision of the requested services/products.

Providing data for the purpose referred to in point 4 (video surveillance) is optional, but if you refuse, access to our offices will be guaranteed.

The provision of data for the purposes referred to in point 5 is optional: you can freely decide not to provide us with any given or to deny us the possibility of using the data, without this preventing us from guaranteeing you the service.

How we process your data

The security of your data is guaranteed through the implementation of appropriate technical and organizational measures. We guarantee that your data will not be processed using automated decision-making processes.

How long do we keep your data? Your data will

be kept for the entire duration of the relationship and for the subsequent 10 years.

For the purpose referred to in point 4 (video surveillance), the images will be stored for 72 hours.

Who we share your data with Your

data may be shared with the following parties:

- employees and collaborators of the Data Controller, professional firms, consultants, IT service providers and other carefully selected and promptly trained parties external to our company; public bodies and administrations;
- credit and financial institutions, insurance companies.

Some of the individuals listed above are appointed as Data Processors; the complete list of appointments is available at the Data Controller's headquarters.

What are your rights?

You may exercise at any time the right to access, rectify, delete, or limit the processing of your data.
